| <b>Guarantor:</b>                                                   | We may require a guarantor to enter into a Guarantor Agreement with us. The Guarantor will be responsible for paying the fees in the event of default by the resident. | <b>Changes to Funding Arrangements:</b>                             | If there is a change in how your care is funded, we may require that you pay an additional payment. For example, if you become eligible to receive state funded care (whether through your local authority or the NHS) the amount the state pays us may not be sufficient to meet our fees and either you or a family member may have to pay an additional fee/top up to meet the difference. If you or a family member is unwilling or unable to pay this additional fee/top up payment you may be required to move to a less expensive room if one is available or we may terminate your placement.                                                                                                        |
| <b>Fee increases:</b>                                               | <p>We review our fees annually on 1st April. We increase our fees by up to 10% per annum. Fees will not increase within the first 6 months of placement.</p> <p>We may also increase our fees other than at the annual fee reviews if your needs change, requiring more or less care/specialist care, you stop receiving FNC contributions (and you become liable for our Total Fee), or there is some unanticipated regulatory change which increases our costs. Self funding individuals will need to provide three months up front.</p> <p>We will provide you with notice before increasing your fee. If it is not accepted, we will give you the option to terminate our agreement without penalty.</p> |
